SUMMARY

Offer Price and net proceeds from the Share Offer

The Offer Price has been determined at HK\$0.28 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

Based on the Offer Price of HK\$0.28 per Offer Share, the amount of net proceeds from the Share Offer to be received by the Company, after deducting underwriting fees, commissions and estimated expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$30.2 million. For details regarding the use of net proceeds, please refer to the paragraph headed “Net proceeds from the Share Offer” in this announcement.

Applications under the Public Offer

The Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 7,915 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and by **electronic application instructions** given to HKSCC via CCASS and through the **HK eIPO White Form** service under the **HK eIPO White Form** for a total of 506,536,000 Public Offer Shares, equivalent to approximately 25.33 times of the total number of 20,000,000 Public Offer Shares initially available under the Public Offer. Due to the very significant over-subscription in the Public Offer, the adjustment mechanism as described in the section headed “Structure and conditions of the Share Offer – The Public Offer – Reallocation” in the Prospectus has been applied. A total number of 40,000,000 Offer Shares have been reallocated from the Placing to the Public Offer. As a result of such reallocation, the final number of the Public Offer Shares is 60,000,000, representing 30% of the total number of the Offer Shares available under the Share Offer. The 60,000,000 Public Offer Shares have been allotted to 5,821 applicants who made valid applications for the Public Offer Shares.
